- All Medicare Supplement plans are eligible for the Underwriting Holiday for an effective date of **May 1, 2022**.
- Application must be received with a **signature date** between **April 1, 2022, at 12 a.m. through April 30, 2022, at 11:59 p.m.** Applications for these plans must be received during this time to be eligible. **Use GA code 99 when submitting applications.**
- Competing health plan members\*\* are welcome to enroll in any available Blue Shield of California Medicare Supplement plan without answering any health questions or underwriting approval.
- Must be a California resident to apply.
