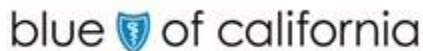

Important Questions	Answers	Why This Matters:
<b>What is the overall deductible?</b>	<b>\$0</b> per individual for <u>HMO participating providers</u> (Level I). <b>\$300</b> per individual / <b>\$600</b> per family <u>participating and non-participating providers</u> (Level II & III).	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your deductible?</b>	Yes. <u>Preventive care</u> and services listed in your complete terms of coverage.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost-sharing</u> and before you meet your <u>deductible</u> . <b>Are there other deductibles for specific services?</b>	No.	You don't have to meet <u>deductibles</u> for specific services.
<b>What is the out-of-pocket limit for this plan?</b>	<b>\$1,500</b> per individual / <b>\$3,000</b> per family for <u>HMO participating providers</u> (Level I). <b>\$4,000</b> per individual / <b>\$8,000</b> per family <u>participating providers</u> (Level II). <b>\$6,000</b> per individual / <b>\$12,000</b> per family <u>non-participating providers</u> (Level III).	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.
