  - **Off-cycle changes:** Only employees impacted by the plan changes will be available to select for bulk plan changes.
  - **Open enrollment changes:** All employees will be available to select for bulk plan changes.
- **Eligibility Options part-time and full-time coverage:** Adjust your group's coverage rules to add or remove part-time employee benefit coverage. [Watch the tutorial video here.](#)
- **Federal COBRA employee ID card download:** Order or download ID cards for Federal COBRA employees from the member account page in EET.
- **User interface and search improvements:** Improvements to the navigation, readability, and organization of the EET along with reduced time to display employee roster search results.
