We're excited to share GREAT NEWS about recent changes to our Trio HMO-IFP provider network that may benefit your clients in specific Southern California regions.

**Effective as of January 1, 2025:**

- **Optum Health Plan of California** groups (formerly Healthcare Partners) are now part of the **Trio HMO-IFP Network**.
  - This includes all groups under Optum Health Plan of California except AppleCare and OCN-Central LA.
  - AppleCare and OCN-Central LA are not affected, as they were already participating in both the Group Trio and Trio-IFP networks prior to 2025.
  - This expansion impacts our Los Angeles **Regions 15** and **16**.
- **Monarch Healthcare**, an affiliate of Optum, is also in the Trio-IFP Network as of January 1, 2025.
  - This expands provider access in South Orange County (**Region 18**).
