

Benefit Solutions discount

The more you add, the more you save. Your clients can save up to 3% on their medical rate by bundling dental plans, vision plans, and life insurance plans together with their medical benefits.*

Benefit Solutions discount does not apply to selffunded dental, vision, and supplemental life plans. Voluntary plans are eligible as long as voluntary is already in place, and they have 50% participation.

Available to fully-insured and ASO self-funded medical groups of 101-1,000, the savings are based on how many products are added.

- · Choose dental and save 2%.
- · Add vision, save another 0.5%.
- Add a minimum of \$25,000 life insurance and save an additional 0.5%.

Quick Match Program

We can match the current carrier's rates with our Quick Match ProgramSM, available for basic life and AD&D, as well as supplemental life and AD&D. This program provides streamlined underwriting by matching rates from any other plan for new and existing groups of 101-499 eligible employees.

- Quick Match for basic life and AD&D Matches
 the current carrier's in-force rates on amounts up
 to \$300,000 and/or multiple-of-salary between
 one and three times the annual salary, with a
 maximum of \$500,000.
- Quick Match for supplemental life and AD&D –
 Matches the current carrier's in-force rates for either
 multiple-of-salary plans between one and five times
 the annual salary with a maximum of \$500,000 or
 incremental plans between \$10,000 and \$500,000
 (not to exceed five times the annual salary).

Three-year rate guarantee

All new groups receive a three-year rate guarantee on their life insurance coverage, giving them added financial predictability for budgeting and planning.

Ease of administration
