  - a. Intolerance to prior oral and IV bisphosphonate therapy that would cause discontinuation, or contraindication to oral and IV bisphosphonates
  - b. Patient experienced a non-traumatic fracture while on a bisphosphonate
  - c. *Through 10/31/2025:* Patient has had intolerable gastric side effects to a monthly oral bisphosphonate regimen
  - d. Inadequate response, as evidenced by documented worsening BMD
- 3. Not being used in combination with other drug therapy for osteoporosis (e.g., Forteo, Evenity, teriparatide, Tymlos)
- 4. Request for Conexxence, Prolia, or Stoboclo: Effective 1/1/2026 and after, will require Intolerable side effect or contraindication with preferred denosumab product (i.e. Jubbonti) that is not expected with the requested drug

#### **Covered Doses:**

Up to 60 mg given subcutaneously once every 6 months

Yearly based on continued response to therapy

# <u>Increase BMD in Patients with Prostate Cancer undergoing Androgen Deprivation Therapy</u> Meets medical necessity if all the following are met:

- 1. Patient is currently taking androgen deprivation therapy [e.g., gonadotropin-releasing hormone (GnRH) agonists such as leuprolide (Lupron)] or has had surgical castration
- 2. Meets ONE of the following:
  - a. Intolerance to prior oral and IV bisphosphonate therapy that would cause discontinuation, or contraindication to oral and IV bisphosphonates
  - b. Patient experienced a non-traumatic fracture while on a bisphosphonate
  - c. *Through 10/31/2025:* Patient has had intolerable gastric side effects to a monthly oral bisphosphonate regimen
  - d. Inadequate response, as evidenced by documented worsening BMD
- 3. Not being used in combination with other drug therapy for osteoporosis (e.g., Forteo, Evenity, teriparatide, Tymlos)

4. Request for Conexxence, Prolia, or Stoboclo: Effective 1/1/2026 and after, will require Intolerable side effect or contraindication with preferred denosumab product (i.e. Jubbonti) that is not expected with the requested drug

### Osteoporosis

# Meets medical necessity if all the following are met:

- 1. Meets ONE of the following:
  - a. One or more non-traumatic fractures
  - b. T-scores less than -2.5 S.D
  - c. T-score is between -1.0 and -2.5 and patient is at high risk for fracture [e.g. multiple risk factors, 10-year hip fracture probability >/= 3%, a 10-year major osteoporosis-related fracture probability >/= 20% based on USA-adapted WHO absolute fracture risk model (FRAX risk assessment)]
- 2. Meets ONE of the following:
  - a. Intolerance to prior oral and IV bisphosphonate therapy that would cause discontinuation, or contraindication to oral and IV bisphosphonates
  - b. Inadequate response, as evidenced by documented worsening BMD with a bisphosphonate
  - c. Patient is initiating or continuing long-term glucocorticoid treatment (≥3 months)
  - d. Patient is at very high risk of fracture by meeting at least ONE of the following:
    - i. Fracture while taking a bisphosphonate
    - ii. Patient has experienced a recent fracture (within the past 12 months) or history of multiple fractures
    - iii. Patient experienced a fracture while on long-term glucocorticoid therapy
    - iv. T-score less than -3.0
    - v. Patient is at high risk for falls
    - vi. 10-year hip fracture probability of > 4.5% based on FRAX score
    - vii. 10-year major osteoporosis-related fracture probability > 30% based on FRAX score
- 3. Not being used in combination with other drug therapy for osteoporosis (e.g., Forteo, Evenity, teriparatide, Tymlos)
- 4. Request for Conexxence, Prolia, or Stoboclo: Effective 1/1/2026 and after, will require Intolerable side effect or contraindication with preferred denosumab product (i.e. Jubbonti) that is not expected with the requested drug

Up to 60 mg given subcutaneously once every 6 months

### **Summary of Evidence**

After reviewing the information in the above resources, the FDA-approved indications listed in the prescribing information for Prolia are covered in addition to the following:

- Prevention of osteoporosis in osteopenic postmenopausal women
- Prevention or treatment of osteoporosis during androgen deprivation therapy for prostate cancer in patients with high fracture risk
- Maintenance or improvement in bone mineral density in patients receiving adjuvant aromatase inhibition therapy

## **Explanation of Rationale**

- Support for FDA-approved indications can be found in the manufacturer's prescribing information.
- Support for using biosimilars as step requirement is found in Noridian Health Care Solutions
  and supported by the FDA. Noridian will accept a biosimilar drug on the same criteria as the
  drug to which it is a biosimilar unless an article is published to the contrary. Per the FDA, a
  biosimilar is highly similar to and has no clinically meaningful difference from an existing FDA
  approved biologic reference drug.
- Support for using biosimilars in oncology can be found in The NCCN Clinical Practice
   Guidelines in Oncology (NCCN Guidelines®) via the footnote on the reference product (an FDA-

- approved biosimilar is an appropriate substitute) and in the NCCN Drugs & Biologics Compendium<sup>®</sup> by the notation that a biosimilar agent may be an appropriate substitute for the reference product.
- Support for using Prolia for the prevention or treatment of osteoporosis during androgen deprivation therapy is found in the National Comprehensive Cancer Network's guideline for prostate cancer. The NCCN Guideline for prostate cancer supports the use of Prolia as prevention or treatment of osteoporosis during androgen deprivation therapy in patients with high fracture risk.
- Support for using Prolia to maintain or improve bone mineral density and reduce the risk of
  fractures in postmenopausal patients receiving adjuvant aromatase inhibition therapy is found
  in the National Comprehensive Cancer Network's guideline for breast cancer. The NCCN
  Guideline for breast cancer supports the use of Prolia in postmenopausal (natural or induced)
  patients receiving adjuvant aromatase inhibition therapy along with calcium and vitamin D
  supplementation to maintain or improve bone mineral density and reduce the risk of fractures.
- Support for using bisphosphonates or Prolia for osteoporosis at high risk for bone fracture is found in several treatment guideline:
  - o The 2022 ACOG Clinical Practice Guideline on the Management of Postmenopausal Osteoporosis supports the use of antiresorptive agents (i.e., bisphosphonates and denosumab), which have broad-spectrum antifracture efficacy, as first-line therapy for most patients with osteoporosis and elevated fracture risk.
  - The 2020 AACE/ACE Clinical Practice Guidelines for the Diagnosis and Treatment of Postmenopausal Osteoporosis states that alendronate, denosumab, risedronate, and zoledronate are appropriate as initial therapy for most osteoporotic patients with high fracture risk.
  - The 2020 Endocrine Society Guideline Update on the Pharmacological Management of Osteoporosis in Postmenopausal Women recommends bisphosphonates as initial treatment and denosumab as an alternative initial treatment in postmenopausal women at high risk for fractures

- Effective 1/1/2026 and after, request for Conexxence, Prolia, or Stoboclo will require an
  intolerable side effect or contraindication with preferred denosumab product (i.e. Jubbonti) that
  is not expected with requested drug (Rationale: Cost effective alternative)
- Osteoporosis:
  - Removed management of bisphosphonate duration of use in patients who have documented worsening of BMD (Rationale: 2020 AACE Practice Guidelines for Osteoporosis)
  - Coverage Period: updated from indefinite to yearly based on continued response to therapy
- Increase BMD in patients with prostate cancer undergoing androgen deprivation therapy or with hormone-response breast cancer undergoing hormone ablation therapy: (Rationale: 2020 AACE Practice Guidelines for Osteoporosis)
  - Clarified prior use of oral and IV bisphosphonate therapy
  - Removed management of bisphosphonate duration in patients who have documented worsening of BMD
  - Effective 11/1/2025, will remove qualifying criteria of gastric side effects to a monthly bisphosphonate
  - o Coverage Period: Clarified that reauthorization is based on continued response to therapy
