Subject: All Plan Letter 23-018: Managed Care Health Plan Transition Policy Guide

The Department of Health Care Services (DHCS) recently issued <u>All Plan Letter (APL) 23-018</u>, "Managed Care Health Plan Transition Policy Guide." We are sharing a summary of this APL with you to ensure you are aware of the information, and you can apply the information to your practice or facility operations, where appropriate.

APL 23-018 introduces a new DHCS policy guide for supporting members transitioning between different managed care plans (MCPs) due to county-driven MCP model changes, changes to commercial MCP contracting, and a new direct contract with a specific MCP. Other reasons for transitioning between MCPs (such as a member choosing to change their MCP) are not covered by the new policy guide.

## How the MCP transitions will affect you – for San Diego providers only

As a result of Medi-Cal contract changes, starting January 1, 2024, Blue Shield of California Promise Health Plan will be receiving new members from two exiting MCPs in San Diego County. We look forward to this opportunity for growth and ask you to help us support new members as they transition to our plan. Please reach out to new members to schedule initial appointments and find out if continuity of care is needed.
